This qualification reflects the role of educators in early childhood education and care who work in regulated children's education and care services in Australia. They support children's wellbeing, and development in the context of an approved learning framework. Educators use a range of well-developed skills and knowledge using discretion and judgment when carrying out their work in the context of established policies and procedures. They may work independently or under the guidance of others, though in some contexts that guidance may not be onsite. Early childhood educators work in long day care centres, family day care, pre-schools or kindergartens.

The C3G program supports eligible individuals to complete their first post-school Certificate III level qualification and increase their skills to move into employment, re-enter the workforce or advance their career.

Eligibility Requirements

- 15 years of age or over and no longer at school
- A Queensland permanent resident
- An Australian or New Zealand citizen, Australian permanent resident (includes humanitarian entrant), temporary
 resident with the necessary visa and work permits on the pathway to permanent residency
- Not hold and not be enrolled in a Certificate III or higher-level qualification
 (Certificate III qualifications completed whilst at school will not exclude you from accessing this funding)
